The deforcians acknowledge the premises to be the right of the plaintiffs

For this agreement the plaintiffs gave £100 sterling to the deforcians.

Rent: 1d. p.a.

**Wetherby**

DD59/R/10/12 MARKET CHARTER

15 Nov.1240

Grant by King Hen.III to the Knights Templars of a weekly market at Wetherby on a Thursday and an annual fair there on the vigil, the feast and the morrow of St. James the Apostle (feast day 25 July) in place of the weekly market at Walshford on a Tuesday and an annual fair at Walshford on the vigil, the feast of St. John the Baptist and the two following days which the King granted previously. (feast day of the Nativity of St. John 24 June)
