Hyde Playte, Rector of Leathley, granted to Thomas de Craven of Stainburn and Agnes, daughter of John Nellson, and the heirs of their bodies...  
"1 messuage with garden and all land etc. etc. which I had of the gift and grant of the same Thomas, in Stainburne," to have and to hold, for ever.
