

DD240 BEAMSLEY HOSPITAL

This collection consists of 4 boxes of documents relating to the Almshouses at Beamsley, near Skipton, founded in 1593 by Margaret, Countess of Cumberland and completed and maintained by her daughter Lady Anne Clifford. They continued as such until the 1970s when they were acquired by the Landmark Trust and are now used as holiday cottages.
