- /1 Lease & release to undertake seisin in a recovery between John Brookesbanke of Mirfield, yeoman of the 1st part, Edward Waugh of Quarmby & John Dyson of Newhouse in Slaithwaite, yeoman of the 2nd part & James Brooksbank of South Crosland & John Parkin of Whiggincroft in North Crosland, clothier of the 3rd part relating to Over Hey and Over Royd in Linthwaite & North Crosland**
