INTRODUCTION

The provenance of this collection is not clear. It was presented to the Society by Hugh T Fattorini who acquired it at auction in September 1984. It is thought previously to have been the property of Robert Clough.

The collection relates, at least partially, to the estates of the Wilsons of Eshton, and the documents in it relate very closely to a large number of those in the Bradfer Lawrence collection (MD335).

There is further Wilson material at Bradford District Archives, the Brotherton Library, Leeds University and Lancashire Record Office.
