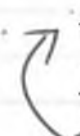

Readers should note that these books generally (except where noted above and in the case of the last volume) cover all of Craven, but not the Cumberland and East Riding manors. Nor, so far as is known do they include commissions to officers. Wardships, tithes etc are generally to be found towards the end.

The quality of the books varies enormously; some are arranged in strict place order, while others have been kept more as day books. Equally, there are wide variations in their physical condition. One volume [36C/3] is at the moment under repair [Dec 1978]. [K...]
