DEEDS

1. 1542. Letters Patent to Leonard Beckwith, esq., granting him the reversion of Selby mills, the manor of Wollas and lands in Wollas, Appleton, Bolton Percy, etc. Great Seal (damaged)
2. 1568. May. Exemplification of a Fine levied in the Court of Common Pleas when Thomas Gerrarde and Robert Worsley acknowledged the manor of Houlthorpe to belong to Francis Slingsby.
3. 1568. November. Exemplification of a Common Recovery suffered in the Court of Common Pleas when Francis Tanckard and Henry Benson recovered against Francis Slingsby the manor of Houlthorpe. Fragment of seal.
4. 1573/4. Letters Patent of Queen Elizabeth granting to George Lamplugh (for services rendered during the rebellion in the Northern Parts) the manor of Sygeston alias Sedgeston, Carleton Nunyate and Sandhutton. Great Seal (broken)
5. 1595. Inspeximus of Queen Elizabeth granted at the request of Henry Slingsby, esquire, out of the Court of Wards and Liveries, being the exemplification of the Inquisition taken on the death of Leonard Beckwith, knight. Seal damaged.
6. A bundle of deeds labelled "Deeds during the reign of Eliz. illustrative of the descent and dignities of the Slingsby family", as follows:-
  - a. 1567. Exemplification granting housebote, firebote and fuel in the Forest of Knaresborough to Francis Slingsby.
  - b. 1569. Grant of a capital messuage and 2 carucates of land in Scriven and the Office of Master Forester by Francis Slingsby to the use of himself and his wife.
  - c. 1574. Grant from Marmaduke Coghill to Francis Slingsby of land in Scriven subject to a rentcharge.
  - d. 1576/7. Assignment of lease of manor of Slingsby and castle for the unexpired residue of a term of 60 years, to Gilbert Holroid.

- e. 1577. Release from Thomas Hunt of a recognizance entered into by Francis Slingsby.
- f. 1578/9. Letters Patent to Francis Slingsby of the Office of Keeper of Bilton Park, Porter of the Castle of Knaresborough, Forester of Wardale, Swynden Okeden Harlowe and Fulwith in the Forest of Knaresborough.
- g. 1580. Order that Francis Slingsby should pay £100 to the Queen's use as surety for Richard Radclif late Receiver.
- h. 1582/3. Lease from William Plumpton to William Slingsby of Bilton Park of Wyntringham Hall in Knaresborough.
- i. 1588. Letters Patent to Henry Slingsby of the Office of Receiver and Collector in Knaresborough, Wakefield, etc. in the Honour of Pontefract. Seal of Duchy of Lancaster.
- j. 1588. A Commission to revive a fair and market in Knaresborough. Duchy of Lancaster seal.

- k. 1588. Surrender to the Queen and re-grant to Francis Slingsby of the bailiwick of Knaresborough and Hay Park at a fixed rent.
- l. 1592. Assignment from Francis Slingsby to Henry Slingsby of all his leases.
- m. 1592. Special Licence from the Crown for George Harvey and Frances his wife and Henry Slingsby and Frances his wife (in the right of the wives, co-heirs of Roger Beckwith) to inherit the possessions of Roger Beckwith.
- n. 1595. Agreement between George Harvey and Frances his wife, Henry Slingsby and Frances his wife, Mauger Vavasour of Weston and William Tankerd, concerning Moorbye co. York, part of the possessions late of Roger Beckwith.
- o. 1595. Bargain and Sale from Henry Slingsby of Scriven to Arthur Atye of Middlesex of a moiety of the manor of Hampstead co. Middlesex.
- p. 1598. Release from Henry Slingsby to Sir Robert Stapleton of all lands late of Brian Stapleton in Carleton, Askam Bryan co. York and Kentmyer co. Westmorland.
- q. 1602. Letters Patent to Sir Henry Slingsby of the Offices of Keeper of Bilton Park, Porter of Knaresborough Castle, Bailiff and Coroner of Knaresborough.

Several good seals, especially of the Duchy of Lancaster.

- 7. 1604. Special Livery granted out of the Court of Wards and Livery to Sir Henry Slingsby, knt., son and heir of Francis Slingsby late of Scriven esq., of all lands etc. held in capite by the said Francis. Great Seal – good condition.

8. 1632. Letters Patent from Charles I to Henry Slingsby knt, William Slingsby knt, and Henry Slingsby esquire, son and heir of the said Henry and Thomas Slingsby, of the manor of St Roberts, 6 messuages, a mill, etc. in St Roberts, Knaresborough and Appleton. Great Seal – broken.

9. 1637. Grant in perpetuity from Charles I to Thomas Lord Fauconberg of the Rectory and Advowson etc. of Sygeston alias Sedgeston, co. York. Great Seal – good condition.

10. 1640. Special Livery granted to Sir Henry Slingsby bart. out of the Court of Wards and Liveries to enter into the lands etc, held in capite by his late father Sir Henry Slingsby knt. Great Seal - good condition.

11. 1670. Letters Patent granting the Office of Constable and Keeper of the Castle of Scarborough to Sir Thomas Slingsby. Great Seal - cracked.

12. 1673. Exemplification of a Common Recovery suffered at Westminster when James Vosper and Richard Pearse recovered the manor of Black Torrington and other lands in Devon. Great Seal - damaged.

13. 1676. Marriage Settlement of Charles Turner and Margaret Cholmley. Dowry £6700. Settling the manor of Kirkleatham, Everby (Ureby), Cotham (Cottam), the mansion house, rectory, tithes, etc, of the manor of Ireby, Sigston, Kildale, Dighton [lists tenants and their holdings] to uses as set out.

Great Seal.

15. 1692. Exemplification of a Common Recovery suffered in the Court of Common Pleas at Westminster when John Savile esq. recovered lands etc. in Scaglethorpe, Redhouse and Moor Monkton. Great Seal - damaged.

16. Bundle of deeds relating to leases of various lands in Sigston granted by John Turner of Kirkleatham. [paper and parchment]

17. 1720/1 Exemplification of a Common Recovery suffered at the Court of Common Pleas at Westminster when James Collins recovered messuages, lands, etc. in Knaresborough.
